ACVIM Associate Membership Status

As you will be aware, the College has been committed to raising its domestic and international profile as well as maintaining our relationships with

our international colleagues. As a result of significant work by many members and the staff of the College I am very pleased to announce that the College has been advised that the American College of Veterinary Internal Medicine has recently launched a new level of formal recognition with the development of the ACVIM Associate Status. The purpose of Associate Status of the ACVIM is to provide an avenue for Colleges like ours to participate in the activities of the ACVIM and to share in the many of the benefits afforded to the ACVIM Diplomats.

Associate status of the ACVIM is open at both the Specialty College and individual Chapter. Our College has been invited to apply for Associate Status as

our credentialling process (residency training, examinations and publications) is comparable to that of respective ACVIM specialities. Benefits recognition include a simplified application process for College members to become ACVIM Associates. For individual veterinarians, Associate status can be obtained via a streamlined process if the applicant's College has received Associate Status, or through submission of individual credentials. The benefits of Associate Status to individuals include qualification to apply for ACVIM Foundation grants, reduced fees for ACVIM educational programs and the ACVIM Forum (including priority registration for limited attendance events), the potential to participate in resident supervision as dictated by the individual ACVIM speciality, and the potential to serve on committees of the ACVIM College (except the Board of Regents) or serve on certain committees of the ACVIM Specialty.

This is an important step for the advancement of our College internationally. Associate Membership of the ACVIM allows for supervision of residency programs of ACVIM Diplomats. This is similar to the agreement we have in Europe with ECVS. College Council is very pleased with these achievements and the increased international understanding and recognition of our College. I wish to thank all those who have worked so hard to improve our International standing.

As always I am available if any problems arise. Fond regards to all College members and their families at this time of the year.

CURRENT COLLEGE STATISTICS

The College currently has a strong membership base of 2203; 1702 of which are Members, 225 are Fellows, 15 are Honorary Fellows, 42 are Associate Members, and 219 are Life members or Life Fellows. 1705 (77%) reside in Australia, 282 (13%) in New Zealand and 216 in other countries.

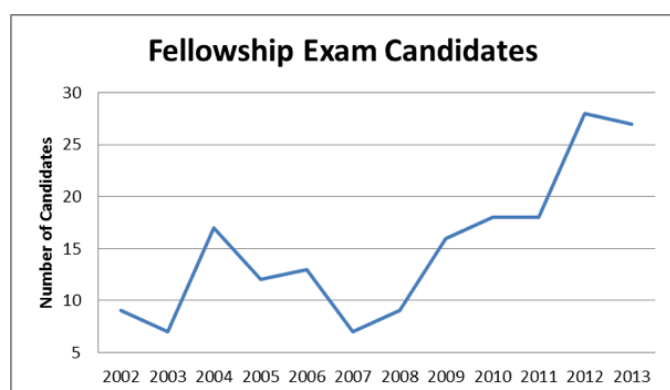
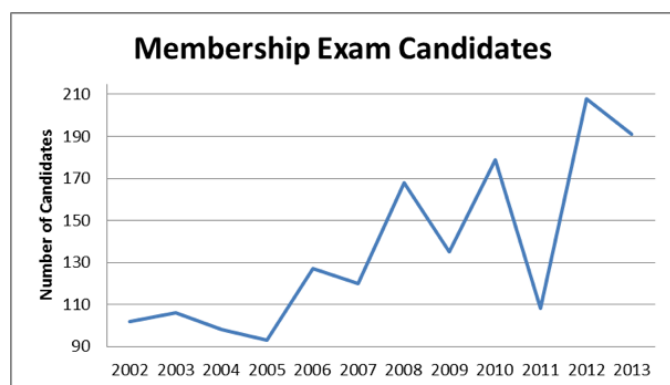

Examiner training workshop

The Board of Examiners has determined that they will run an exam writing workshop on the weekend of 2 and 3 February next year in Brisbane; this initiative is envisaged to significantly assist examiners, and increase the efficiency and effectiveness of the exam writing process. It has been approved by Council and an Examination Development Fund approved for this purpose. The workshop to be facilitated by Professor Glen Coleman will focus on assisting examiners with writing all components of the Fellowship and Membership examinations, from the initial examination blueprint to actual construction and wording of questions and the review process.

Fellowship and Membership subjects in Small Animal Surgery, Small Animal Medicine; and Membership Subjects in Veterinary Emergency and Critical Care and Medicine of Cats have been selected as the subject areas for focus in 2013. The Head Subject Examiners for each of these examinations will be invited to attend, plus one other examiner and the Chapter Examination Committee liaison. It is envisaged that local examiners in other disciplines may also attend to assist with the exam preparation in their respective subjects.

All examiners in participating subjects will be expected to have considered the broad subject areas they wish to cover and to have contributed to draft examination questions for their exam. The attending examiners will then bring the draft questions along to the workshop. It is envisaged at the end of the weekend that the written, practical and oral examination papers will be finalised.

COMPUTER BASED EXAMINATIONS

CALL FOR INTEREST IN JOINING A WORKING PARTY

The use of computers /keyboards for examinations has been discussed by the Board of examiners for many years and has been unable to be resolved. There are a constant low level of requests for this from candidates citing issues with being able to write fast enough and clearly enough to demonstrate their skills and knowledge. Technical and practical issues complicate the potential for use of keyboards or computers for examinations. These include:

- Provision of equipment, especially when currently we offer examinations in multiple worldwide centres
- Secure lockdown of the equipment to be used to prevent internet access or other communication

Solutions may have to include the limiting of examination centres to 1-2 key centres and this may involve a large cultural change in the examination process.

The use of computers for examinations would afford potential advantages over and above the handwriting speed and legibility issues which include:

- improving the authenticity of assessment
- word processing
- the use of other software eg: excel spread sheets
- the provision of images and video in questions

This issue will persist and the Board of Examiners believes that it is time to put in place some firm long term plans for moving to computer based examining in future. The Board has therefore resolved to form a special working party to investigate and draft options and plans for managing the issue of the use of computers /keyboards for examinations. It is envisaged that the working party comprise interested College members. Interested College members are hereby invited to apply to the Board of Examiners for consideration for joining this exciting working party. Expressions of interest may be made to the College Office.

CHAPTER ACTIVITIES

The World Aquatic Veterinary Medical Association has welcomed the Aquatic Animal Health Chapter (AAH) of the ANZCVS as members as an Allied Veterinary Organisation. While the ANZCVS serves as primarily a credentialing body for veterinarians, the WAVMA has a complementary role in serving the discipline of aquatic veterinary medicine through developing CPD programs, identify, foster and strengthen professional interactions among aquatic medical practitioners and other organisations around the world.

With the Aquatic Animal Health Chapter joining WAVMA as an AVO, both organisations stand to gain in a multitude of ways in the synergistic partnership to optimally position and advance the discipline of aquatic veterinary medicine, and support the practice of aquatic veterinary medicine globally.

This partnership will foster more discussion between professionals, making it easier to address global issues which affect us all; a larger group will generate more discussions on Listservs and provide greater response to consultations; and it will bring greater visibility within the AVO which will create greater awareness for WAVMA's activities (e.g. promoting conferences, continuing education opportunities, WAVMA member's business, etc.) and hence influence to the wider veterinary community.

Dr Richmond Loh has been elected to serve as WAVMA's president in 2014.

Our very own Dr Richmond Loh, will be president-elect of the World Aquatic Veterinary Medical Association in 2013, graduating to the presidency position in 2014.

This will bring Australia to the forefront of global aquatic veterinary medicine and foster stronger relationships between aquatic veterinarians worldwide. During his term, he seeks to promote and convince fellow veterinarians that we can do well to serve in the field of aquatic animal health. "Once we can convince ourselves that we can do it, then we can convince our clients (aquaculturists, fish owners, public aquaria, etc.) that we can do it."

Dr Loh was admitted into the College in 2006 after passing his exams in Aquatic Animal Health and later, received his Memberships in Pathobiology. He is currently serving on the Aquatic Animal Health board as their Secretary.

Aquatic Animal Health Chapter presented on the ANZCVS's credentialing system at the NOVICE Conference in Bucharest, Romania.

The Network Of Veterinary ICT (information and communications technology) in Education (NOVICE) that started in 2010 which is supported by EU funds, is a *professional network* that enables its members (veterinarians,



veterinary students, ICT educationalists or veterinary educationalists) to exchange knowledge and expertise throughout Europe and beyond. During October 4th - 5th, 2012, a conference was held with an aquatic stream with two themes, '*Supplementing Veterinary Curricula & CEPD with Aquatic Veterinary Medicine*' and '*Promoting Aquatic Vet Education through NOVICE & Other Social Media*'.

The selection of presentation topics drew a number of the 100 plus attendees from Europe and around the world, stimulating good discussions.

Dr Loh, Secretary of the Aquatic Animal Health Chapter, presented on the state of aquatic specialisation programs via a pre-recorded presentation, focussing on the ANZCVS's Membership and Fellowship examinations.

OPHTHALMOLOGY

The Chapter's interim meeting this year at Silky Oaks Lodge, Mossman was a great success. Professors Chris Murphy and Joanne Paul-Murphy from the UC Davis School of Veterinary Medicine gave a series of fascinating lecture presentations on avian and exotic ophthalmology and optics.

The Ophthalmology Chapter will also be contributing speakers to next year's International Society of Veterinary Ophthalmology (ISVO) weekend meeting in Auckland, 9th and 10th March 2013. The ISVO meeting will be held in association with the WSAVA 2013 Congress, and includes both international veterinary ophthalmologists and the Magrane Memorial Lecture to be delivered by Professor Anthony Molteno, Head of Ophthalmology at Otago University School of Medicine. The meeting is open to anyone interested in Ophthalmology, so please contact the Chapter if you are interested in attending.

The Ophthalmology Chapter is planning another exciting programme for the 2013 Science Week meeting, with details available in the next issue of the Courier.



RADIOLOGY

The Radiology Chapter will be splitting its Membership stream into a Small Animal and Large Animal stream with separate exams from 2014. Previously the Radiology Membership has focussed predominantly on small animals with only part of the examination dedicated to large animal (equine) cases. From 2014, candidates will be able to select which stream they would prefer to sit in. It is anticipated the Large Animal stream will focus on predominantly equine radiology, but may incorporate some other production animal radiography, whereas the Small Animal stream will focus on predominantly dogs and cats (with no equine or large animal questions).

The Chapter hopes that this change will make the discipline more appealing to many practitioners, as they may not need to worry about studying up on species that they rarely (if ever) see. For those in mixed practice who are keen, they are able to sit in both streams (but not in the same year). For those enrolled in Fellowship training programs for Radiology, obtaining Membership in either stream will be acceptable for credentialing.

No new Radiology Chapter exams will be conducted in 2013 so the next opportunity to obtain Membership in Radiology will be in 2014.

Science Week 2013:

The Radiology Chapter will be actively involved in College Science Week 2013. We have invited Dr Erik Wisner from UCD to speak to the Radiology Chapter and in combined sessions with the Equine and Small Animal Medicine Chapters. The Chapter is looking forward to an inspiring 2 day session held over the Thursday and Friday of CSW.

SMALL ANIMAL MEDICINE

Once again the focus of the SAM chapter over the past few months has been organising examiners and associated support people for the 2012 membership and fellowship examinations. This has been challenging, especially at fellowship level as we rely on the generosity and support of all our fellows.
